# Courses Offered

## BA., LL.B (Hons.)

The Bachelor of Arts and Bachelor of Law (Honors) is a 5 years integrated program with a multi-disciplinary approach to cater to the requirement of the field of law including litigation, judiciary, academia, corporate legal consultation, immigration, public international law and private international law, policy engagement et cetera. The students of this integrated course will also learn the subjects of liberal arts such as English, History, Sociology, Political Science, besides Law & Economics. This program provides a strong background to step into Indian Administrative Services too.

## BBA., LL.B. (Hons.)

The Bachelor of Business Administration and Bachelor of Law (Honors) is a 5 years integrated program to focus on interrelationship of Management Studies and Law. Besides, the Fundamentals of Management, Financial Accounting, Effective Communication, and Computer Application are some of the main subjects of the business part of the BBA LLB (H) Program, while the Law Subjects include Law of Torts, Constitutional law, Criminal law, Civil wrongs, Administrative law, Company law, Property law, Family law, Alternate Dispute Resolution, and soon.

## B.Tech., LL.B.(Hons.)\*

The Bachelor of Technology and Bachelor of Law (Honours) is a 6 years integrated program that combines the depth and comprehensiveness of the legal system with the technicalities of engineering. The students are exposed to various subjects such as Mechanical engineering, Computer Science Engineering, Civil Engineering, Computation and Mathematics on the engineering side, intellectual property rights, cyber laws, AI policy, robotics law, drone laws and space laws from the law part. The dual degree program blends knowledge and skills, making it a highly sought-after course in both the legal and engineering sectors.

## LL.B. (Hons.)

Bachelor of Law- LLB (Honors) is a 3 years program that familiarizes students intimately with the teaching methodologies and legal research of both national and international characters keeping in view the different types of legal systems, especially in Common Law traditions as well as Civil Law system as practiced in India. It enables students capable of analysing and examining the economic, cultural and political impact of enacted laws. The course fosters study and research into legal theory and values; examines the relationship between theory and practice; and enhance opportunities for scholarly research, writing, and publication.

## Ph.D. in Law

LLM (Hons.) is a specialized 2-year postgraduate program offering advanced knowledge and law expertise. It is designed to provide a deeper understanding of the legal system and equip graduates with the skills necessary to excel in the legal profession. It contains various legal laws, from Civil law, Corporate law to Cyber laws. With its rigorous curriculum and specialized focus, LLM (Hons.) is an excellent choice for those looking to advance their legal careers and make a meaningful impact in their respective fields.
