Strengthening the Entrepreneurial Ecosystem in Academia:

AIC Mahindra organised Faculty Development Programme (FDP) to equip faculty to nurture innovation

A standout feature of the program was a visit to T-Works, India's largest prototyping centre, providing hands-on exposure to innovation in action.
