**BBA,LL.B.(Hons.):** The Bachelor of Business Administration and Bachelor of Law (Honors) is an undergraduate integrated program to focus on interrelationship of Management Studies and Law. Besides, the Fundamentals of Management, Financial Accounting, Effective Communication, and Computer Application are some of the main subjects of the business part of the BBA, LL.B. (Hons.) Program, while the Law Subjects include Law of Torts, Constitutional law, Criminal law, Civil wrongs, Administrative law, Company law, Property law, Family law, Alternate Dispute Resolution, and so on.

**B.A., LL.B. (Hons.):** The Bachelor of Arts and Bachelor of Law (Honors) is a undergraduate program with a multi-disciplinary approach to cater to the requirement of the field of law including litigation, judiciary, academia, corporate legal consultation, immigration, public international law and private international law, policy engagement et cetera. The students of this integrated course will also learn the subjects of liberal arts such as English, History, Sociology, Political Science, besides Law & Economics. This program provides a strong background to step into Indian Administrative Services too

**B.Tech., LL.B. (Hons.):** It is a six-year integrated and industry-backed dual-degree program that seeks to fill the demand gap for engineers, who shall also have expertise in law; thereby embracing the future with a new breed of professionals in the legal-tech domains. This pioneering program uniquely combines engineering principles with legal knowledge to address the emerging challenges of technologies like AI, blockchain, cryptocurrency, and data science. This interdisciplinary approach equips students with the technical expertise and legal acumen necessary to navigate the complex landscape of these technologies. The curriculum is designed to provide a balanced education, covering core subjects in technology, such as computer science, information technology, and engineering principles, alongside essential legal studies, including constitutional law, contract law, intellectual property law, and dispute resolution. This interdisciplinary approach fosters critical thinking, analytical skills, and a nuanced understanding of how technology impacts legal frameworks.

- 10+2 or equivalent from any statutory board with 60% OR as per AICTE/UGC norms aggregate marks in all subjects OR equivalent grade for the students from IB or other approved Boards.
- Valid CLAT 2026 examination score (Exact cut off score / All India Rank would be announced upon announcement of results).

**OR**

- A valid **LSAT Test Score**

**OR**

- Qualify in Mahindra University Law Entrance Test-2026 ( MULET 2026 )

### **B.Tech.,LL.B.(Hons.) Programmes' Eligibility Criteria**

Qualify in JEE (MAIN) 2026 examination and be eligible to write the JEE Advanced 2026  
Or Top All India Rank in JEE (MAIN) 2026 examination (Exact cut off rank would be displayed upon announcement of results).

A valid **SAT Subject test Score (which should include Mathematics, Physics, Chemistry) – minimum 1800**

A valid **SAT Test Score ( Min. 800 )**

A valid **ACT Score ( Min. Composite Score 18 )**

Qualify in Mahindra University Law Entrance Test-2026 ( MULET 2026 )

### **For the B.Tech., LL.B. (Hons.) Programme**

- Academic Fees: **Rs. 5,00,000 per annum** (All Inclusive Academic Fees)
- Hostel Charges: **Rs. 1,70,000 per annum** (All Inclusive Hostel & Mess Charges) [mandatory to reside on campus] - **Triple Occupancy Rooms**
- Caution Deposit: **Rs. 20,000** (Refundable at end of study and graduation)

**(Note: Hostel residence is mandatory for students enrolled in the B.Tech., LL.B. (Hons.) programmes. Hostel stay is not mandatory for students of the B.A., LL.B. (Hons.) and BBA, LL.B. (Hons.) programme & all fees are subject to revision every year.**

Accommodation shall be provided in accordance with the University's standard norms. During the first academic year, all students will be allotted triple-occupancy rooms. From the second year onwards, students may have the option to opt for double or triple occupancy, subject to availability, with hostel fees applicable as per the allotted accommodation type.)
