## School of Law Ph.D. Program Admission Notification (Academic Year 2026-27)

Mahindra University, notified by the Government of Telangana vide Telangana Ordinance No. 1 of 2020 dated 20th May 2020, invites applications for its Ph.D. programme at the School of Law, commencing in Aug'26.

The Doctor of Philosophy Programme (Ph.D.) offered by the School of Law (SOL), Mahindra University is strategically aimed at fostering high-quality research that contributes to the creation of new knowledge. These Ph.D. regulations draw from the guidelines established by the University Grants Commission (UGC).

The first year would require the Ph.D. candidate to go through a set of prescribed course work, which shall be followed by an initiation to research and comprehensive examination, along with evidence-based actual research work carried out under a Ph.D. Adviser from the respective field.
